The Special Meeting of the Board of Directors of the Cherokee Metropolitan District was held on Tuesday, January 30, 2024 at 5:30 p.m. at 6250 Palmer Park Blvd., Colorado Springs, Colorado.

ITEM 1: Call to Order

The meeting was called to order by Director Wall at 5:30 p.m. Jeremy Atkinson was asked to lead those in attendance with the Pledge of Allegiance. All five Directors were present and there were no Directors' qualifications or disclosures.

ITEM 2: Review and Approval of the Agenda

The Agenda was reviewed for any changes. Director Wall asked that 3.A, Directors Comments, be added to the Agenda.

MOTION: DIRECTOR WALL MOVED, SECONDED BY DIRECTOR KINNEY, TO APPROVE THE JANUARY 30, 2024 AGENDA AS AMENDED. MICHELLE MARIE KINNEY-YES. TRACEY FERGERSON-YES. LINDA L. KELEHER-YES. STEVE HASBROUCK-NO. DAN WALL-YES. MOTION PASSED (4-1).

Director Wall wanted to pay tribute to three soldiers who were killed at their site near the Syrian border by a drone attack last Sunday. Also, he wanted to respectfully recognize two Navy Seals who were killed in action on January 11.

ITEM 3: Public Comments

There were no public comments.

ITEM 4: Action Items/Reports

The Springside parcels were brought to the table for discussion. Director Kinney stated on June 20, 2023, the Board voted 4-1 to correct the titles for two parcels, commonly known as 2386 Springside Dr and 2395 Springside Dr. She stated the vote was not honored.

Director Fergerson also stated General Counsel provided Director Kinney with the quit claim deed to obtain the authorized signatures to file with the District Court. Director Wall felt that the District should continue to maintain those parcels as they have been maintained by the District the past 20 years.

Kevin Brown led a discussion on the PFAS pilot study and provided the Board and those in attendance with an updated report. There were six companies that provided bids: Hazen & Sawyer, Garver, Geosyntec, JVA, Inc., Burns & McDonnell, and Kimley-Horn. Of those six companies, three companies, Hazen & Sawyer, Garver, and Geosyntec have advanced to the next step of interviews which will take place starting February 2. There was discussion and questions from the audience regarding chlorine and water hardness, and other water quality concerns.

The next discussion was regarding the DEO conflict waiver and designation of the District's DEO. Director Fergerson stated that in a discussion with Wayne Williams, he informed her there was not a conflict to accept the seat of DEO, and that it was just a matter of the judge appointing him.

Director Hasbrouck questioned the present discussion of a DEO stating this year was not even an election year. It was the Board's consensus that a DEO would not need to be appointed until 2025. Mrs. Lathen stated Mr. Williams would be required to sign a Waiver of a Conflict of Interest should he be appointed the District's DEO, since he was one of the attorneys the District hired to help with the class-action PFAS lawsuit.

Mrs. Lathen provided an overview of Parcel #3500000015, which is the parcel directly south of the WRF's RIBS located at 19495 Enoch Road, Colorado Springs.
