RESOLUTION 2018-11

A RESOLUTION OF THE BOARD OF DIRECTORS OF THE CHEROKEE METROPOLITAN DISTRICT REVOKING RESOLUTION 2018-10 AND THEREBY AMENDING THE 2018 SCHEDULE OF TAP FEES AND CHARGES APPLICABLE TO DISTRICT SERVICES,

WHEREAS, C.R.S. §32-1-1001(j) authorizes and empowers the Board of Directors of the Cherokee Metropolitan District (the “District”) to fix and from time to time increase or decrease fees, rates, tolls, penalties, or charges for service, programs or facilities furnished by the District; and

WHEREAS, C.R.S. §32-1-1006(l)(g) authorizes and empowers the Board of Directors of the District to fix and from time to time increase or decrease tap fees; and

WHEREAS, after a duly noticed Public Hearing held on December 17, 2018, the Board of Directors of the District has determined to adopt the attached Exhibit A, reflecting the tap fee rates and charges that shall be applicable to customers and rate payers of the District.

NOW THEREFORE, be it resolved by the Board of Directors of the Cherokee Metropolitan District as follows:

The Cherokee Metropolitan District 2018 tap fee rates and charges attached hereto as Exhibit A are hereby approved and effective December 17, 2018.
